2024 renewal period closes with positive outcomes



The 2024 EMS certification renewal period has come to an end. From April 1st to the present, the department processed a total of 1701 applications and addressed 206 IT support requests with an average resolution time of under 11 hours.

A significant decrease in expired certifications was reported this year, with only 55 EMS clinicians failing to renew compared to 371 in 2023. The final list of expired certifications has been shared with relevant agency licensure representatives.

Moving forward, EMS clinicians who need to renew their certifications after this period will be required to submit a reinstatement application. DC Health encourages clinicians to utilize the "support" function on the DC Health portal for any assistance.

This course is designed to provide a comprehensive understanding of capnography for all perioperative staff and anesthetic trainees. By exploring the fundamental principles of capnography, analyzing EtCO2 waveforms, and interpreting their significance in ventilated patients, participants will develop a strong foundation in this essential monitoring tool. While tailored to the perioperative environment, the underlying science of capnography is equally relevant to EMS providers who utilize this technology in their clinical practice. This course will equip learners with the knowledge to effectively apply capnography across various healthcare settings. (Course is Free)

Essentials of Global Health - Yale

Essentials of Global Health is a comprehensive introduction to global health. It is meant to introduce you to this topic in well-structured, clear and easy to understand ways. Much of the course will focus on five questions: What do people get sick, disabled and die from; Why do they suffer from these conditions? Which people are most affected? Why should we care about such concerns? What can be done to address key health issues, hopefully at least cost, as fast as possible, and in sustainable ways? The course will be global in coverage but with a focus on low- and middle-income countries, the health of the poor, and health disparities. Particular attention will be paid throughout the course to health systems issues, the linkages between health and development, and health matters related to global interdependence. The course will cover key concepts and frameworks but be practical in orientation. (Course is Free)
