## OS-1217-08 LEGISLATIVE UPDATES - OFFICE OF GOVERNMENT RELATIONS

**Ms. Kera Johnson**, Legislative Affairs Specialist, to report on the following:

#### Community Health Amendment Act of 2025

 The legislation authorizes healthcare providers in the District to order and administer immunizations recommended by competent medical and public health organizations designated by the Director of the Department of Health. The legislation will also allow pharmacies to administer the COVID-19 vaccine without a doctor's prescription.

#### Medical Debt Mitigation Amendment Act

 This legislation aims to prevent and mitigate the burden of unpaid medical debt bills on District families, while increasing transparency in medical billing and ensuring fair debt collection. The high-level summary of the bill would be to strengthen large health care facilities financial assistance policies, create protections to mitigate the burden of medical debt, update medical debt collection practices, and establish legal enforcement and oversight.

#### PrEP DC Act of 2025

• This legislation would prohibit health benefit plans and health insurers from using prescription information as a condition of eligibility or to set premium rates. It would prohibit insurers from restricting or imposing delays in the distribution of antiretroviral prescription drugs prescribed to a person for the treatment or prevention of the human immunodeficiency virus (HIV) or acquired immunodeficiency syndrome (AIDS). It would also prohibit health insurers from imposing a deductible, coinsurance, copayment, or other cost-sharing requirement for PrEP or PEP to prevent HIV and AIDS infection.

#### Council Recess

 The Council will go on Winter Recess starting on December 23, 2025 until January 2<sup>nd</sup>, 2026. The first Legislative Meeting in the new year will be January 6, 2026.
