OS-1117-05	<p><b><u>BOARD ATTORNEY'S REPORT:</u></b> Board Counsel, Ms. Carla Williams, Esq. discussed several new policies:</p> <ol style="list-style-type: none"> <li>1) <b>Temporary Waiver of DC Take Home Law Exam for Dentists and Dental Hygienists.</b> This policy temporarily waives the DC law exam requirement for licensure for both license types while the Board finalizes the new Law Exam based on the updated regulations.</li> <li>2) <b>Temporary Waiver of Limits on use of Approved Internet Continuing Education Courses for Renewal, Reinstatement or Reactivation.</b> This policy temporarily waives the limitation on use of online continuing education courses for Dental Assistants as well as Teaching licenses for Dental and Dental Hygienist license types for the duration of the public emergency.</li> <li>3) <b>Health Professionals Reporting Requirements.</b> This policy requires all licensed, registered, and certified health professionals in the District and their employers, to report certain disciplinary and/or terminations to the respective authorities within specified timeframes.</li> <li>4) <b>ABRA Medical Cannabis Prescription Thresholds.</b> DC Alcohol Beverage Regulation Administration (ABRA) is seeking from several Boards, including the Board of Dentistry, a threshold number of Medical Cannabis recommendations from an authorized practitioner within a 12-month period, which would require ABRA to notify the Board.</li> </ol> <p><b><u>BOARD ACTION</u></b> <b>Motion:</b> The Board to determine fifty (50) as the threshold number of Medical Cannabis recommendations from an authorized practitioner within a 12-month period which would require ABRA to notify the Board.</p> <p><b>Moved by:</b> Dr. Iris Jeffries-Morton, (Board Member) <b>Seconded by:</b> Ms. Dianne Smith, Esq., (Board Member) <b>Motion passed unanimously.</b></p>
