

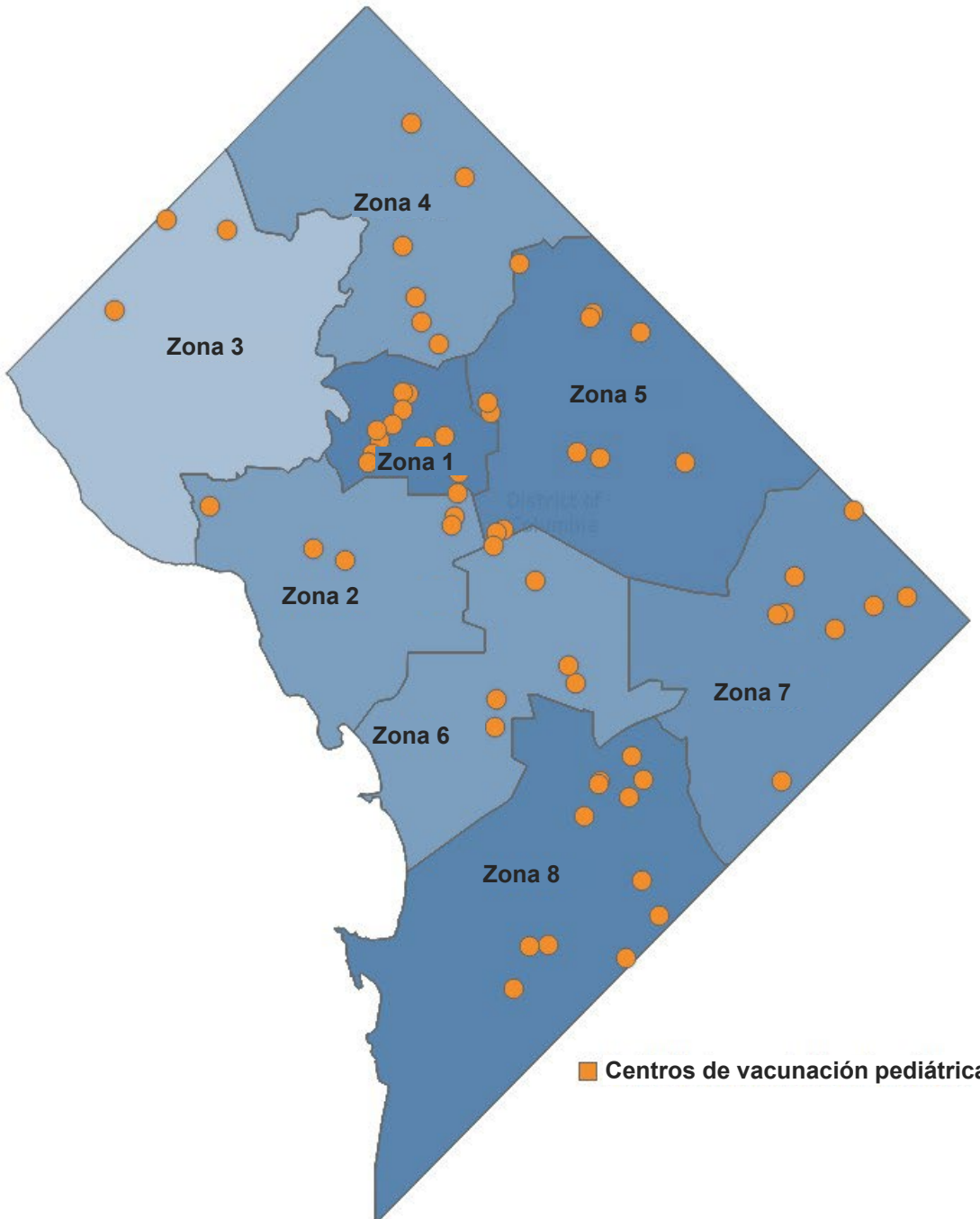

contra COVID-19/Coronavirus

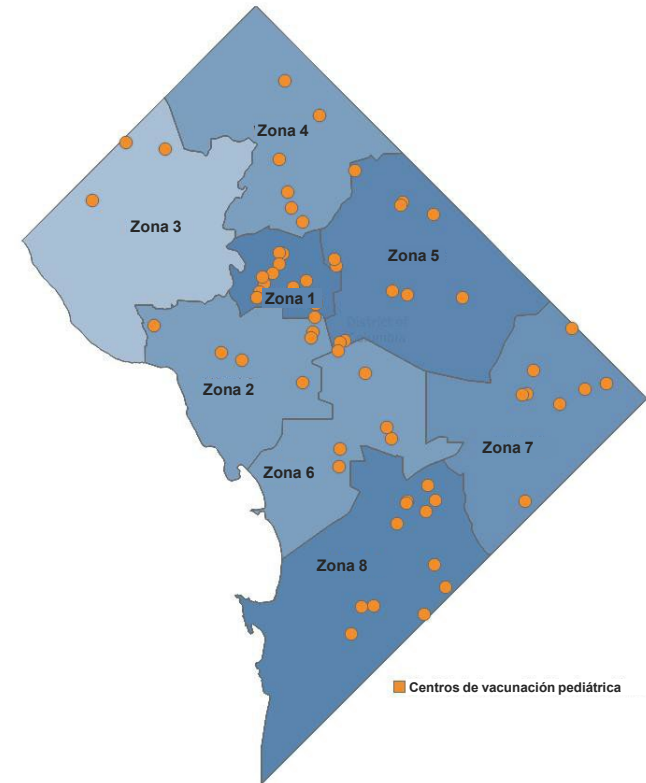
