All health professional boards have been asked to look at their scope of practice definitions and provide any recommendations and/or feedback regarding changes they would like made. Currently, the scope of practice definition is the same for both professions. In the past, the Board had discussed potentially combining the licenses and having one license type. The regulation's for nutritionist has been recently revised and going through the proposed rulemaking process.
