	Board Action:
	To review the current guidelines in place by Centers for Medicare & Medicaid
	Services regarding IV Renal Dialysis Medication, Etecalcetide.
	Background:
	CMS is requiring this medication be included in the reimbursement bundled
	payment to providers. It was officially bundled January 2021 after allowing
	providers to have a 2 year trial/grace period where it was not included and
	therefore reimbursed separate from other bundled renal therapies. During this 2
	year period its use clinically has been outstanding. This in turn has changed the
	way in which providers advise patients. New provider guidelines are advising and
	requiring that clinicians reduce or remove patients from this medication and
	instead start preparing these patients for work up for a parathyroidectomy
	surgery; essentially shifting the cost outside of the renal provider and placing a
	possibly undue burden of surgery on the patient.

	The Health Occupation and Revision Act is currently being updated. All health
	professional boards have been asked to look at their scope of practice definitions

	professions. The SubCommitte conducted a review of the scope of practice and
	provided feedback regarding updates and corrections to the regulations.
