Call to Order	Lamont C. called the meeting to order at 5:05 pm, followed by a moment of silence and introductions.		
Review and Adoption of the Agenda	Lamont C. assumed the motion to adopt the agenda for March 17, 2022. The agenda was adopted with the noted change.		
Review and Approval of the Minutes	Lamont assumed the motion to approve the meeting minutes for February 17, 2022. There were no corrections to the minutes. The motion was approved as presented.		
	The committee is working on the logistics for the DMV History Project. The initial meeting will be a kickoff to the training that will review the goals of the project, discuss the kind of information to obtain from the interviews, and give key information to the interviewers including more information about narrative storytelling to help the interviewers in the process. Emily indicated that the link is still open for people to submit pictures of people and landmarks for the project.		
	Lamont introduced Regina J. of the Places of Worship Advisory Board (POWAB). Regina indicated that POWAB had created a historical timeline of HIV events from its beginning to the present in 2010. They found gatekeepers, and people who were HIV positive who told their stories and created an extensive map of activities.		
	Ken indicated that the committee we should proceed with the history project by adding onto the work that has already been done and approaching it in terms of Ending the Epidemic.		
DMV History Project Update	The committee determined that the in-person training on Thursday April 14, and the virtual training on April 21, 2022 doesn't allow enough time to push the registration and let people know about the project or execute any of the outreach ideas that were brainstormed at the last meeting. Anthony G. asked if the training should be moved to the CEEC meeting scheduled for May 19, 2022.		
	Anthony indicated that he is scheduled to present the COHAH General Body, a Protocol Implementation Toolkit training with Trina on the April 28, 2022. Anthony wants to see if there is interest in having a more robust conversation around protocol implementation best practices for same day PrEP and Rapid Start. He is also looking to have a summit for the DMV area, and inviting some agencies to share their implementation process. Anthony further indicated that Gilead is willing to sponsor the event.		
	At the April 2022 CEEC meeting, the committee will have more discussion about a potential summit some time in June, July or August, and who to engage. Anthony indicated that the summit would be more impactful if the COHAH and DOH was involved and could provide CEUs. Lamont indicated
