AGENDA

ITEM	DISCUSSION
Call to Order	Jenné M. called the meeting to order at 5:06 pm, followed by a moment of silence and introductions.
Review and Adoption of the Agenda	Sharon C. motioned to adopt the agenda for July 22, 2021. Philip S. seconded. The agenda was adopted unanimously.
Review and Approval of the Minutes	Sharon motioned to approve the May 20, 2021 Meeting Minutes. Philip seconded. The minutes were approved unanimously.
DMV History Project Update	<p>Ken P. indicated that Montgomery County's June event, Michael K.'s departure from the administration in addition to not having a meeting last month left movement on the DMV History Project stalled. There was discussion amongst the committee about how to coordinate the trainings for the people who would do the interview sessions.</p> <p>Emily H. added that the project started as an idea for a labor of love. It was to begin with a collaboration with the Baltimore City Health Department (BCHD) Innovations Team who was working on the HIV Health Museum, a project very similar. BCHD was going to support us with some story collection that would fit into our framework. However, some critical things had changed and Baltimore is no longer able to assist.</p> <p>Emily gave a brief overview of the original conception of the DMV History Project.</p> <p>The purpose was to :</p> <ul style="list-style-type: none"> • Honor the many people that came before Ending the Epidemic (EHE) • Create HIV history landmarks where critical people did many important things. • Collect stories we are afraid will be lost to time • Create intergenerational conversations <p>Anthony G. suggested establishing an ad hoc group to assist with the project that can exist for the life of the project. Ken P. indicated that he brought the idea to the CEEC because he believes it is a strong committee in terms of numbers and what the committee is trying to accomplish. Emily talked about what the sessions might look like. In addition to collecting stories, she would like to ask people who have been around for a while about some of the physical spaces in Montgomery county where people went in the early days to feel safe and trusted. She would host some actual conversations in those spaces, asking questions like: What was it like? What did it feel like to be in those moments? How do you think things have changed? Tie the history and the people to that physical space. Jenné indicated that the CEEC is capable of handling this sort of project and that it falls in line</p>

	<p>with what the committee is charged with. She further indicated that besides the Community Listening Sessions (CLSs), many of the tasks on the CEEC work plan have changed or been combined with something else, making room for CEEC to be involved, if the committee, as a whole, agrees and is interested.</p> <p>Anthony suggested asking AmeriCorps members, and the like, to assist with some of the administration components of the project. Ken said it is something we can explore. Ken further indicated that we do not want to over exhaust the community with the community engagements. As part of the EHE Initiative, Ken and Anthony recently had a survivor's dinner. The participants talked about isolation, and their needs. Another event is scheduled for tomorrow with trans women, and an intergenerational conversation is scheduled for August. Ken indicated that we must figure out how to leverage the opportunities across the different groups to inform the work that the committee is looking for.</p> <p>Jenne motioned to have CEEC participate in the DMV project. Anthony seconded. The motioned was approved unanimously.</p>
<p>Planning CLS</p>	<p>Jenné reminded the committee that at the last CEEC meeting they agreed to come to the next meeting with ideas on how to move forward with the CLS. Some of the questions were:</p> <ul style="list-style-type: none"> • Should there be a focus on particular groups or header topics? • Who should these groups be? • Should the decision be data driven or should the COHAH be polled? <p>Jenné considered what was just discussed about the DMV History Project, and indicated that it might make sense to take a step back and plan more strategically so that information obtained in the CLS will also inform the DMV History Project and vice versa. It may also help shape some of the topic areas and/or groups. Topics/groups discussed were as follows.</p> <ul style="list-style-type: none"> • <u>Gender Identities</u> - Sharon indicated that she has had conversations with teachers who are struggling with conversations with youth who want to be recognized by their gender identity. It is a topic that is relative to the youth in Prince Georges County. Teachers do not know how to address it. Derek C. thinks it is a great idea, however, anything involving schools would have to go through the school board which is very difficult. Ken indicated that HAHSTA no longer conducts sex education in the schools, however, they continue to do testing. He further indicated that assembling a group of professionals to start some sort of dialogue isn't something that has to go through the school board. Jenne wanted to discuss what that conversation would look like. Should it be a panel or a focus group? What should we do first? Phil suggested addressing the teachers as well as social workers because of the close partnership between the two.



	<ul style="list-style-type: none">• <u>Churches</u> - Sharon also mentioned churches that are opening back up and suggested speaking to or attending POWAB who already has an established base of faith leaders and associations as another platform for this topic.• <u>African born community</u> - Ken asked if CEEC had done any work in the past with the African born community. Jenné said no, but it had been suggested previously. Ken informed Jenne that HAHSTA, COHAH, Montgomery County are all interested and can be used as resources.• Hard of hearing/Deaf community - Anthony suggested. <p><u>Next steps - Start brainstorming about</u> Who we will need to contact to put something together for this (i.e. LGBTQ coordinators, etc.) Who we are inviting in to act as our panelist/ speakers or experts as well as how we want to engage staff and any other group/s. Pull together resources around this topic area. Who are the stakeholders? Do we need to do some kind of focus group first?</p>		
CEEC 2020 Work plan Discussion	The Work plan discussion was tabled. Jenne will make some suggested edits for the next meeting.		
Announcements and Adjournment	<p>Anthony is having a patient dinner on Thursday of next week at 5:00 pm at the Busboys and Poets. The specific location is to be determined between the S.E. and Monroe St. N.E. locations. The event is open to anyone living with HIV. There will be the branded Gilead presentation and live discussion with a couple of patients that are living with HIV. They will tell their share their experience and facilitate any questions the clients may have.</p> <p>Ken if we can catalog and calendar some of the events it also can add to this work of amplifying the needs of our community. Come up with 1 or 2 questions for these groups that are meeting. Put a placeholder for next meeting to decide what the 3 to 5 questions might be.</p>
