Call to Order	Lamont C. called the meeting to order at 5:05 pm, followed by a moment of silence and introductions.							
Review and Adoption of the Agenda	Hearing no changes to the June 20, 2024, Agenda, Lamont assumed the motion to adopt the agenda as presented.							
Review and Approval of the Minutes	Hearing no corrections to the May 23, 2024, Meeting Minutes, Lamont assumed the motion to approve the minutes as presented.							
Workplan 2024 Discussion	Lamont indicated that every year the committees develop work plans. CEEC is in a unique position that offers more flexibility in what they are able to do because there are no federally required mandates governing the committee. Last year CEEC was focused on the Protocol Summit. Now is a good time to start thinking about what the committee will do in the next fiscal year that begins in October. The Ryan White Conference in August and the USCHA Conference in September are two opportunities to hear from colleagues around other EMAs, TGAs and Planning Councils to gather ideas to bring back to the committee. The conferences also offer opportunities to speak, present and volunteer but you must apply early. Lamont further indicated that the doesn't have to do all the heavy lifting for all of the activities considered on the workplan. Collaboration with other agencies is allowed and encouraged. Jenné M. is beginning to plan for the D-Seeing Project exhibits. Some of the exhibits will be tied into some of the different HIV awareness days.
