<p><b>Protocol Implementation Summit Updates</b></p>	<p>No updates reported.</p>
<p><b>Youth Summit Update</b></p>	<p>Alan J. reported on the Youth Services Coalition meeting that was held today to get a sense of the World AIDS Day activities anticipated from other organizations. Another group, the Youth Services Team, met yesterday and discussed if time around World AIDS Day would be a good time to engage young people for a testing and engagement event. Time around Valentine Day was also discussed considering the youth event funds will be available until then. A work plan must be developed, and updates will be given once a more formalized plan is in place. Alan further indicated that the HAHSTA's Youth Team had an event at the DC Health and Wellness Clinic last week. Some of the lessons learned will inform upcoming events. <p><b>Other Business</b></p>	<p><u>USCHA Debriefing</u></p> <p>Lamont reported on his experience at the conference. People appeared to be inspired and received a lot of good information. Overall, he enjoyed the conference, however, rooms filled so quickly he was not able to attend some of the events.</p> <p>Alan echoed Lamont's sentiment. One of his key takeaways was the presentation given by the Dandelions Youth Group at the plenary, who spoke about their experiences with perinatal HIV and the need to be included at the table.</p> <p>Derrick C. also attended and had a wonderful time learning and fellowshiping. He noted the presence of a few famed attendants namely Maxine Waters, Sheryl Lee Ralph, and Yolanda Adams. He was moved by the reading of "A Love Letter to Black Woman" at one of the events.
