Call to Order	Lamont C. called the meeting to order at 5:06 pm, followed by a moment of silence and introductions.



Review and Adoption of the Agenda	Lamont assumed the motion to adopt the agenda for September 15, 2022. The agenda was adopted as presented.		
Review and Approval of the Minutes	Lamont assumed the motion to approve the meeting minutes for August 18, 2022. There were no corrections to the minutes. The minutes were approved as presented.		
Protocol Implementation Summit Update	<p>Anthony G. indicated the biggest hurdle in planning the summit has been finding space. After not hearing back from Gallaudet University he was finally able to secure a space at the Human Rights Campaign (HRC) at 1640 Rhode Island Avenue, Washington, DC. There is no cost for the venue, plenty of room, and food can be catered. However, parking is challenging. It is better to travel via metro, Uber or Lyft.</p> <p>The summit is intended to involve respective Departments of Health in the DMV in giving EPI updates coming out of the pandemic, to hear about how different types of organizations, those who offer medical and those who don't, are implementing Rapid Start/A.R.T. protocols, and some lessons learned, and discuss how we are administering PrEP and looking at similar types of intervention.</p> <p>The summit was scheduled for September 29th which is two weeks away. One way to approach this short timeline is to have it in two parts. Conduct the first part in two weeks and present an updated EHE plan to the community. Conduct part two in November or the end of October although November may not be good or HRC. Lamont added that it is okay to take more time for planning and preparation. Anthony is considering Thursday, October 27th. Patrice B. indicated that the 27th is the EOC and General Body meetings. Anthony suggested making a whole day of it to include a hybrid version of the EOC and General Body meetings.</p> <p>Lamont will work with Jane Wallis and Ashlee Wimberly in coordinating the EHE Plan presentation efforts to include Ravinia from Prince Georges Department and Emily in Montgomery County. Anthony will put together a mock agenda for the meeting from 10a – 4p to start getting feedback. A continental breakfast will be served and a full lunch.</p>
