DEA- Washington Division, Diversion Program Manager (DPM) Justin G. Wood is a distinguished graduate of the Virginia Military Institute (VMI) with a Bachelor of Science degree in Chemistry and completed his Master of Science Degree in Chemistry from the Pennsylvania State University.

DPM Wood join the Drug Enforcement Administration (DEA) in 2004 as a Diversion Investigator for the DEA Nashville District Office in Tennessee where he worked a wide variety of criminal, civil, and administrative cases from 2004 until 2012.

- In 2012, Mr. Wood was reassigned to the Tactical Diversion Squad in the Nashville District Office where he focused solely on criminal investigations involving drug diversion. During this time, Mr. Wood was involved in numerous complex Organized Crime Drug Enforcement Task Force (OCDETF) Investigations involving priority targets.
- In 2014, Mr. Wood was promoted to the position of Diversion Group Supervisor in Birmingham, Alabama where he supervised diversion groups in Birmingham and Mobile, Alabama. In 2016, Mr. Wood also took on the responsibility of overseeing the Diversion Group in Little Rock, Arkansas.
- In June 2018, Mr. Wood transferred to DEA Headquarters Pharmaceutical Investigations Section and subsequently was promoted to the position of Diversion Program Manager for the DEA Washington Division where he oversees diversion operations for the District of Columbia, Maryland, and Virginia.

During his career, DPM Wood has completed training in drug diversion, pharmacy thefts and prescription fraud, basic telephone and internet exploitation, interview and interrogation tactics, and leadership.
