FINAL DECISION AND ORDER OF THE BOARD

This matter comes before the District of Columbia Board of Medicine (Board) following Dr. Sikandar S. Imran, M.D.’s (Respondent) submission of an affidavit, pursuant to D.C. Official Code § 3-1205.17, voluntarily surrendering his license to practice medicine in the District of Columbia.

On March 8, 2018, Respondent pled guilty to the charge of “Fetal Homicide” (Va. Code Ann. § 18.2-32.2) in Arlington, Virginia. Respondent had been jailed since May 24, 2017 when he was arrested for the crime. The Board had been advised of his arrest and, following his conviction, had voted at its April 25, 2018 Board meeting to initiate disciplinary proceedings through a Notice of Intent.

On May 18, 2018, Respondent was sentenced to twenty (20) years confinement in state prison, of which seventeen (17) years was suspended; probation for fifteen (15) years following his release from prison; and, as Respondent is not a U.S. citizen, prohibited from re-entering the United States if deported. As part of his please agreement Respondent also agreed to immediately forfeit all licenses to practice medicine; Respondent voluntarily surrendered his license to practice medicine in the District of Columbia on May 18, 2018. He submitted an

affidavit of surrender, pursuant to D.C. Official Code § 3-1205.17, completed with the assistance of his defense counsel, Peter Greenspun. The affidavit of surrender is attached to this Order.

The Board accepts the surrender of the license and the Board has determined to revoke Respondent's license to practice medicine, pursuant to D.C. Official Code § 3-1205.17(b).

ORDER

ACCORDINGLY, UPON CONSIDERATION of the foregoing, it is by the District of Columbia Board of Medicine,

ORDERED, that the VOLUNTARY SURRENDER of Sikandar S. Imran, M.D.'s, License No. MD043879, BE and is hereby ACCEPTED, pursuant to D.C. Official Code § 3-1205.17; and it is further

ORDERED, that Sikandar S. Imran, M.D.'s, License No. MD043879, BE and is hereby REVOKED, pursuant to D.C. Official Code § 3-1205.17(b); and it is further

ORDERED, that the foregoing is a FINAL ORDER of the District of Columbia Board of Medicine.
