All licenses, registration, and certifications issued on or after this date will expire on the last day of the license holder’s birth month of an odd or even year. As a result, some individuals will receive an expiration date of less than 2 years. <u>BOARD ACTION:</u> The Board to consider the recommendation from DC Health that requires individuals with a license, registration, or certification expiration date of less than 2 years to complete 50% of the standard CEU hours, including all mandatory content areas (such as LGBTQ+ cultural competency and DC Health public health priorities). This is a standard recommendation given to all the Boards by DC Health.
