	During the art therapy subcommittee meeting, the subcommittee discussed the HORA revisions pertaining to art therapy. The subcommittee would like the following amended in the HORA:	
	 Removing provisions related to a doctoral degree in art therapy. Applicants for licensure are only required to complete a master's degree in art therapy. Revising the "supervised practice" requirement to make it clear that 50% of required supervision must be completed by a Roard cortified art therapist supervisor or a licensed art 	
	a Board-certified art therapist supervisor or a licensed art therapist. This ensures licensees complete more supervision with an art therapist.
