The ASPPB is encouraging member boards to join the compact to assist licensees with cross jurisdictional practice and consumers with additional access to practitioners.</p>

In October, the board requested to form voluntary subcommittee who will review the current laws and regulations to make recommendation to the board as it updates the regulations and law.
