She also posted information from the DC Cohort's variables that would be available for REC to request. DeMarc asked if they were adding questions around COVID-19. Natella said that they are developing extensive questions around COVID-19. Ashley Y. said she is working on the Virginia Needs Assessment, and they are putting their survey in Red Cap and will try to work with their rural agencies to reach clients who do not have easy internet access. They hope to launch their survey in September.
