#### **CONSENT ORDER**

This matter comes before the District of Columbia Board of Medicine (the "Board") pursuant to the Health Occupations Revision Act ("HORA") (D.C. Official Code § 3-1201.01, et seq. (2016 Repl.)). D.C. Official Code § 3-1202.03(a)(2) authorizes the Board to regulate the practice of medicine in the District of Columbia. The Board has broad jurisdiction to regulate the practice of medicine and to impose a variety of disciplinary sanctions upon a finding of a violation of the HORA. D.C. Official Code, § 3-1205.14; Mannan v. District of Columbia Board of Medicine, 558 A.2d 329, 333 (D.C.1989). The Council of the District of Columbia, in amending the HORA, "intended to strengthen enforcement of its licensing laws." Davidson v. District of Columbia Board of Medicine, 562 A.2d 109, 113 (D.C.1989). And the HORA "was designed to 'address modern advances and community needs with the paramount consideration of protecting the public interest." Joseph v. District of Columbia Board of Medicine, 587 A.2d 1085, 1088 (D.C.1991) (quoting Report of the D.C. Council on Consumer and Regulatory Affairs on Bill 6-317, at 7 (November 26, 1985)) (emphasis added by court)).

## Background

The Respondent has been licensed in the District of Columbia to practice medicine since March 9, 2012. During the license renewal cycle for the period ending December 31, 2018, the Board conducted an audit of a random number of licensees to determine compliance with the continuing medical education (CME) requirement. Respondent was selected as part of the audit. Respondent was contacted requesting proof of compliance with the Board's CME requirement. Upon receipt of the request for evidence of CME compliance, Respondent was unable to provide evidence of compliance; he attempted to obtain the records he believed were saved in a folder he'd created within a previous work email account, but was informed by his previous employer that this account could no longer be accessed.

Respondent has, therefore, failed to satisfy the Board's CME requirement by fifty (50) credits of CME, including three (3) credits of CMEs in HIV/AIDS courses and two (2) credits of CME in lesbian, gay, bisexual, transgender, gender nonconforming, queer, or questioning (LGBTQ).

# Conclusions of Law

The Board is authorized to sanction Respondent under the HORA for his actions, which are related to the practice of medicine. The HORA provides, in pertinent part:

Each board, subject to the right of a hearing as provided by this subchapter, on an affirmative vote of a quorum of its appointed members may take one or more of the disciplinary actions provided in subsection (c) of this section against any applicant for a license, registration, or certification, an applicant to establish or operate a school of nursing or nursing program, or a person permitted by this subchapter to practice a health occupation regulated by the board in the District who:

(24) violates any provision of [the HORA] or rules and regulations issues pursuant to the HORA[.]

D.C. Official Code § 3-1205.14(a)(24).

The HORA further provides that the Mayor may establish by rule continuing education requirements as a condition for renewal of licenses[.] D.C. Official Code § 3-1205.10(b).

[The Board] shall periodically conduct a random audit of at least one percent (1%) of its active licensees to determine compliance. The physicians selected for the audit shall provide a completed Continuing Education Compliance Audit Form and all supporting documentation to the Board within thirty (30) days of receiving notification of the audit.

17 DCMR § 4615.2.

Physicians actively practicing medicine in the District of Columbia must "submit proof of having completed fifty (50) American Medical Association Physician Recognition Award (AMA/PRA) Category I hours of Board of Medicine approved continuing education credit during a two-year period preceding the date the license expires. DCMR §17-4614.2. Of the requisite fifty (50) hours of continuing education credit, three (3) must be in instruction on HIV and AIDS and two (2) must be in LGBTQ. D.C. Official Code §§ 3-1205.10(b)(4)(A)(i) and (5)(A).

Respondent has violated the foregoing requirements necessary to maintain his license to practice medicine. Accordingly, Respondent's conduct described above provides the Board with a basis in fact and law to warrant disciplinary action.

## **ORDER**

ACCORDINGLY, based upon the foregoing, it is hereby,

ORDERED, that a fine of five thousand dollars (\$5,000.00) be and is hereby imposed upon Respondent for failing to comply with the CME requirement to maintain his licensure requirements, and shall be submitted within sixty (60) days of the effective date of this Consent Order. The fine imposed by the Board shall be made by check payable to the "D.C. Treasurer" and mailed to Lisa Robinson, Health Licensing Specialist, Board of Medicine, 899 North Capitol Street, NE, 2<sup>nd</sup> Floor, Washington, D.C. 20002; and it is further

ORDERED, that Respondent shall submit acceptable proof of having completed the deficient fifty (50) hours of CME credits, including three (3) hours in AIDS/HIV and two (2) hours in LGBTQ instruction, within ninety (90) days of the effective date of this Consent Order. Any hours of CME credit completed in satisfaction of this Order shall comply with 17 DCMR §§ 4614 and 4615, and shall not be used to satisfy Respondent's continuing education requirements for the current licensing period or any subsequent licensing period. CME completed in satisfaction of this Order shall be submitted to Lisa Robinson, Health Licensing Specialist, Board of Medicine, 899 North Capitol Street, NE, 2<sup>nd</sup> Floor, Washington, D.C. 20002; and it is further

ORDERED, that the effective date of this Order is the date it is signed by the Board Chair; and it is further

**ORDERED**, that Respondent shall be subject to a mandatory CME audit for the 2019 - 2020 license renewal period; and it is further

**ORDERED**, that in the event Respondent fails to satisfactorily fulfill the terms of this Order, the Board may issue a notice to take additional disciplinary action against Respondent's license; and it is further

**ORDERED**, that this is a public document.
