FINAL DECISION AND ORDER OF THE BOARD

This matter comes before the District of Columbia Board of Medicine (Board) following Dr. Preeti Rout's (Licensee) submission of an affidavit, pursuant to D.C. Official Code § 3-1205.17, voluntarily surrendering her license to practice medicine in the District of Columbia.

On November 29, 2017, the Licensee's Maryland state medical license was summarily suspended after the Maryland Board of Physicians determined that her conduct constituted a substantial likelihood of a risk of serious harm to the public health, safety and welfare. On December 26, 2017, she entered into a Consent Order with the Maryland Board where her license would be suspended until she was determined to be in compliance with certain terms and conditions.

On January 9, 2018, the D.C. Board of Medicine summarily suspended the Licensee's license as a result of the Maryland Board actions. The Licensee decided not to contest this summary suspension action. Her D.C. medical license expired on December 31, 2018. On February 7, 2019, the Licensee voluntarily surrendered her license to practice medicine in the District of Columbia. Her affidavit of surrender is attached to this Order.

The Board accepts the surrender of the license and the Board has determined to revoke Licensee's license to practice medicine, pursuant to D.C. Official Code § 3-1205.17(b).

ORDER


ACCORDINGLY, UPON CONSIDERATION of the foregoing, it is this 27TH

AFFIDAVIT OF PREETI ROUT

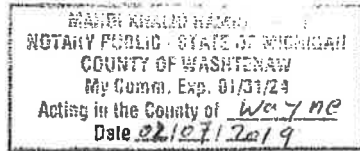
I, PREETI ROUT, M.D., am over the age of eighteen, and I am competent to state the following:
