She had served as a Director of Youth Services and Youth Ministry as well as Local Director of Women's Ministry with the Burns SDA Church in Detroit, Michigan for a combined total of 6 years. She also assisted with the Community Service and Senior Ministries the at Burns SDA Church where her mother Constance Gayles, who is now in her own end -of- life care process with two terminal illnesses, served for more than 20 years. Donna has continuously been instrumental and involved in community outreach and service, being eternally grateful for the full circle that allows her to serve entirely in this capacity with grace, empathy and understanding.

She has provided several community and faith-based trainings to educate and empower our communities with the knowledge that they need to have relevant end of life discussions, including pilot programming for special spiritual engagement projects with Capital Caring Health. Other presentations include those at East River Family Strengthening Collaborative, the Catholic University of America, Howard University Hospital, United Medical Center, Iona Senior Services and various others organizations throughout the region. She's also presented at a vast number of places of worship including The New Macedonia Baptist Church, where Patrick J. Walker, Sr.is the Pastor. Because of this connection, she was a special guest of Pastor Walker's (Also Former President of the Baptist Ministers Conference) at the Baptist Ministers Conference held at the Trinidad Baptist Church where she was afforded the privilege of addressing over 100 ministers, providing them excerpts from her presentation to several congregations throughout Washington, D.C and surrounding areas. She's also severed as a thought leader and moderator facilitating discussions for a number of organizations including the most recent "Faith, Caregivers, and Cancer; Preserve and Strengthen Family Relationships for the Patcha Foundation's CASEC Information Exchange Conference 2019.

As a certified Rosalynn Carter Institute for Caregiving "Dealing With Dementia" Trainer, member of the Age Friendly DC's Caregiving Committee (Co-Chaired By Gail Gibson Hunt, founder of the National Alliance for Caregiving), AARPDC's "Dream Team", DC HEALTH MOST Train-The-Trainer Cohort as well as having served as the former Co-Chair of the Advocacy and Education Committee for DC Health's Places of Worship Advisory Board and now the newly appointed 2020-2021 Co-Chair of the DC Health's Places of Worship Advisory Board (POWAB) at large, Donna continues to trailblaze opportunities in the community to advocate for and support quality of life and care initiatives.
