

The following instructions and requirements apply to applicants who hold one or more of the following active license (s) in the District of Columbia and want to add an additional license type.

- Certified Nurse Midwife (CNM)
- Clinical Nurse Specialist (CNS)
- Certified Registered Nurse Anesthetist (CRNA)
- Nurse Practitioner(NP)

Please review the eligibility criteria before completing your application as the fees are non-refundable.

An applicant is eligible for licensure as a Registered Nurse/Advanced Practice Registered Nurse if the applicant:

- (a) Currently licensed, in good standing, as a Registered Nurse/Advanced Practice Nurse in the District of Columbia.
- (b) Currently licensed or nationally certified, in good standing as an Advanced Practice Registered Nurse under the laws of a state or territory of the United States.

During the online application process, be prepared to:

- Upload a copy of a government issued photo ID such as a driver's license or passport.
- Upload a passport-type photo. Photo should be a front-facing headshot with a plain white background.
- Upload proof of name change- If the name on your application is different from the name on any of your supporting documents, proof of name change is required. Acceptable documents are marriage certificate, divorce decree, court order or spouse's death certificate.
- Pay the application fee of \$119.00 by Visa or Mastercard only.
- Pay the criminal background check fee of \$50.00 by Visa or Mastercard only **if** your last criminal background check with DC Health was completed more than two (2) years ago.

You must request or complete the remaining application requirements through the separate organizations indicated below.

- Criminal background check (CBC) **Fieldprint**- After you make the payment, you will receive an email that includes the code and link to schedule your fingerprint appointment.
- Verification of APRN certification. Contact your certifying body and request that proof of current certification is emailed to the Board of Nursing. Each certifying body has the Board of Nursing's contact and email information on record. **See a list of recognized certification programs below.**
