OS-18-06-02 ALL	<p><b><u>SCOPE OF PRACTICE</u></b></p> <p><b>Board Action:</b> To review existing statutes re: Chiropractic scope of practice in the District and to determine what, if any, changes are necessary to the Chiropractic scope of practice..</p> <p><b>Background:</b> Recently the Board has been engaged in discussions regarding the need to update the legal scope of practice for chiropractors in the District. In response, the Board's Attorney has been researching the issue and found various materials on the topic that may be of assistance to the Board during their discussions. These materials have been presented at prior meetings, following which the Board decided that a dedicated meeting was necessary to work out what scope of practice changes are necessary.</p> <p><b>Motion:</b> The Board members present discussed various ideas on what type of change they'd like to see to the statute and scope of practice. Ultimately it was decided that legal staff will draft new language with the Model Practice Act from FCLB as a starting point, and incorporate facets of the existings language in the HORA. Once completed, it will be placed on the Board's July agenda for review.</p> <p>As this item was for discussion purposes only, no formal action was taken at this time.</p>	AG
