The OAG office<br>needed clarification on "training requirements" that 11311.5<br>intends to exempt.<br>In July 2020, the Board accepted the second proposed ALA<br>Rulemaking. The Senior Deputy Director has reviewed the<br>proposed rulemaking and has questions regarding the<br>qualifications in 11302.1(c) and the requirement of 480 hours of<br>practicum. Wanted clarity regarding why the requirements are<br>more stringent than 11302.1(b). Based on the curriculum for<br>nursing, medicine, and other health professional programs; social<br>services, psychology, some of the core courses are required.<br>The proposed ALA rules were opened to public comments. There<br>are 2 Guardant letters included - one with the board attorney's<br>response and the other one is the comment from the public.<br>In October 2019, the Board addressed the comments from the<br>public.
