• Councilmember R. White introduced the <i>Protecting Health</i>	
Professionals Providing Reproductive Health Care	
Amendment Act of 2022 (<u>B24-0830</u>).	
• This proposed legislation would prevent DC Health licensing	
boards from taking certain actions, including the revocation	
or suspension of a license, against a licensed healthcare	
professional for providing or facilitating abortion services	
when that that service falls within the professional's scope of	
practice, and the disciplinary action is based exclusively on the	
patient residing in a jurisdiction where abortion services are	
prohibited.

Healthcare Career Scholarship & Health Professional Loan	
Repayment Program (HPLRP) Expansion Legislation:
