OS-0313-04 **EXECUTIVE DIRECTOR'S REPORT:**

Mrs. Walker gave the updates on the following:

Dr. Sharon Lewis continues to be Interim Director at DC Health. Mr. Arian Gibson is no longer interim Senior Deputy Director, he has accepted the position of the Office of Senior Deputy Director of HRLA. Mrs. Walker also gave an update on Coronavirus and Monkeypox. Information is available for both pandemics on how the District of Columbia is managing. In addition, you may also see the current procedures and statistics at the websites below. There was an oversight hearing which took place February 28, 2023, with the new chairperson councilman Henderson, to discuss and meet with board chairs, the work of the boards and collaborating with other boards. In addition, there also was a performance oversight hearing which took place March 2, 2023, where Dr. Sharon Lewis was the witness and testified on the behalf of the licensing board at DC Health.

Ms. Drozdoski gave an update on the following:

As of February 24, 2023, the Mandatory Covid-19 vaccination revision act is now a requirement for health care workers who are hired or contracted by or granted privileges or credentialed by a health care facility that is regulated by DC Health. For health care workers that may request an exemption, must request that through the employer or facility. DC Health no longer regulates exemtptions. The Board Attorney also informed the board members that Arian Gibson is now the Office of Senior Deputy Director of HRLA.
