**NOTICE OF SUMMARY ACTION TO SUSPEND LICENSE**

To: Desiree Deutchoua, RN



In accordance with the provisions of the District of Columbia Administrative Procedure Act, D.C. Code § 2-509; the District of Columbia Health Occupations Revision Act of 1985, D.C. Code § 3-1205.15(a); and 17 DCMR § 4118, the District of Columbia Department of Health (D.C. Health) gives you notice of the summary suspension of your registered nursing license, RN1057334, under D.C. Code § 3-1205.15(a).

Your license is **summarily suspended** effective **immediately** upon receipt of this notice. If you wish to appeal this summary suspension of your license, you must file a request for a hearing within 72 hours after service of this notice. Should you request a hearing, one will be held within 72 hours of receipt of a timely request, and a decision will be rendered within 72 hours after the close of the hearing. The request for a hearing must be submitted in writing to Panravee Vongjaroenrat, Assistant General Counsel, D.C. Health. The District of Columbia (the District) is represented by the Office of the Attorney General for the District of Columbia. A copy of your hearing request and any pleading or other written communication addressed to D.C. Health must also be delivered to Shani C. You may appear personally at the hearing, and you may be represented by legal counsel. You have the right to produce witnesses and evidence, to cross-examine witnesses against you, to examine evidence produced, and to have subpoenas issued to require the production of witnesses and evidence.

All hearings are conducted in the English language. If you or any witnesses to be called are deaf, have a hearing impediment, or cannot readily understand or communicate the spoken English language, an application may be made to the Administrative Law Judge for the appointment of a qualified interpreter.

A request for a hearing will not stay the suspension of your license.

The charges upon which the summary suspension is based are set forth below.

**Charge I:**

**You lack the necessary education and training to obtain a Registered Nurse (RN) license, so your active licensure permitting you to provide services to patients in the District presents an imminent danger to the health and safety of the public, for which D.C. Health can summarily suspend your license under D.C. Code § 3–1205.15(a)(1)(D).**

On January 25, 2023, the Federal Bureau of Investigation (FBI) informed the public that individuals were charged with fraud relating to their purchase of fraudulent nursing diplomas from several schools, including Palm Beach School of Nursing (Palm Beach). The FBI determined that the owner of Palm Beach, Johanah Napoleon, conspired to sell fraudulent nursing degree diplomas and transcripts, misrepresenting the diploma recipients as having completed training and education requirements. The fraudulent diplomas and transcripts enabled purchasers to take the National Council Licensure Examination (NCLEX) when they were not qualified.

On June 7, 2022, Mr. Napoleon attested by affidavit that from 2016 to the present, Palm Beach and other schools he owned issued diplomas and transcripts to individuals who never completed the required program hours and clinical training for a practical nursing diploma and transcript or nursing associate in science degree and transcript. Mr. Napoleon identified you as receiving a diploma and transcript without completing the program hours and clinical training.

You applied for licensure based on the examination you took on February 22, 2020, to the Maryland Board of Nursing, indicating you completed Palm Beach's nursing program on November 1, 2017. On February 25, 2020, you obtained your Maryland RN license no. R242756. On March 20, 2020, you obtained your District RN license no. RN1057334 by endorsement based on your fraudulently obtained Maryland license. Your District license is currently valid until June 30, 2024. And as a nurse with a District license lacking the education and training required for a RN license under 17 DCMR §§ 5402.1(a)(2) and 5405.1, as well as D.C. Code § 3–1205.14(a)(1), you present an imminent danger to the health and safety of the public and the District.


**Charge II:**

**Your nursing license was suspended by the State of Maryland and has not been reinstated, for which D.C. Health can take summary action to suspend your District RN license under D.C. Code § 3-1205.15(a)(1)(A).**

On March 6, 2023, the Maryland Board of Nursing summarily suspended your nursing license, under Maryland Code Ann., State Government Article §10-266(c)(2), for providing false/contradictory information about your RN education. The Maryland Board found that you did not meet its statutory and regulatory requirements for RN licensure in Maryland and that your fraudulently obtained RN license poses a serious risk and danger to the public health, safety, and welfare.

A request for a hearing will not stay this summary suspension. Please note that under 17 DCMR § 4103.2, your failure to appear at the time and place set for the hearing, either in person or through counsel, or both, will not preclude the administrative law judge's proceeding in this matter.
