INSTRUCTIONS FOR FOREIGN EDUCATED NURSE APPLICANTS FOR LICENSURE BY ENDORSMENT

The following documents must be uploaded to your application:

- 1. Your copy of the credentials evaluation report that qualified you for licensure in the United States.
- 2. Evidence that the applicant has spoken and written competency in English by documenting one of the following:
 - (a) Graduation from a nursing program in a country where English is the native language and English was the only language of instruction through the applicant's inclusive dates of attendance, as reported on credential evaluation report;
 - (b Successful passage of an English proficiency examination approved by the Board that includes the components of reading, speaking, writing, and listening (See acceptable exams below); or
 - (c) Evidence that the applicant has completed a total of twelve (12) months of full-time employment in the United States during the two (2) years immediately preceding the date of application. *Upload a letter from US employer.*
- 3. Copy of US Government or State issued photo identification.
- 4. 2X2 photo of head and neck front facing with plain white background
- 5. You must attest to being fully vaccinated from COVID. If you received the vaccination in a foreign country, you must request WHO exemption through the Vaccine Reporting portal https://doh.force.com/ver/s/vaccinereporting Be sure to upload a copy of your card. Then, after receiving, upload the approval letter to your application
- 6. Request verification of your original and current license by going to www.nursys.com If originally licensed in PA or MI, you must request directly from their Board of Nursing.

Please note an incomplete application for 90 days or more will be closed.
