BOARD OF PROFESSIONAL COUNSELING LICENSURE CHECKLIST

The Graduate Professional Counselor license is issued to qualified applicants who meet the educational requirements. The license is issued once for a five year period and must be renewed every two years. Remember in order to work in the District of Columbia, you must have a license. This includes working towards your required post-graduate supervision hours.

Please use the provided checklist to assist in the application process. It is **IMPORTANT** to send all of the required documents listed below based on the method by which you are applying for licensure.
