

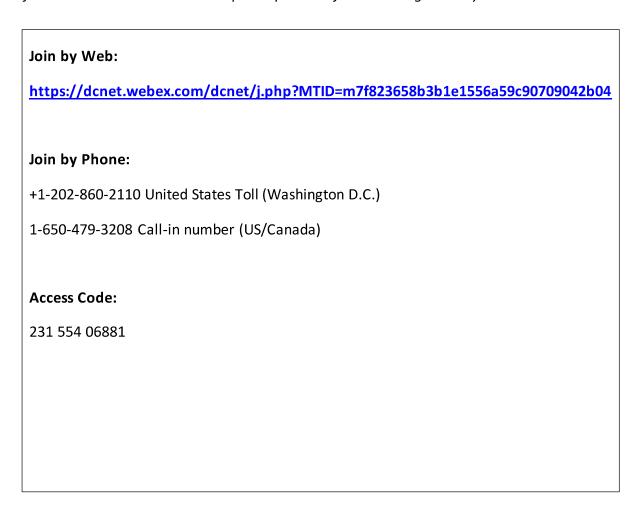

B. BOARD ATTORNEY'S REPORT

i. The Board Attorney introduced the summer legal interns - Frances Ricks, Dana Sartorelli and Trevor Musoke. He reported that the new Board of Acupuncture, Chiropractic and Naturopathic Physicians went into law on June 10th and its first meeting will be on July 8th. He also mentioned that the FSMB would be having a conference meeting on trauma informed care in New Orleans in February 2026 and each Board will be allowed to send one Board member and one Board staff member to it.

D. OFFICE OF GOVERNMENT RELATION'S REPORT FY 2026 Budget:

- The Committee on Health held DC Health's Budget Oversight hearings, one for public witnesses, on <u>June 6th</u> and, one for government witnesses, on <u>June 16th</u>. You can find information about the proposed Fiscal Year 2026 budget <u>here</u>.
 - On June 16th, DC Health Director, Dr. Ayanna Bennett, along with members of the DC Health leadership team testified before the committee, highlighting key accomplishments in FY25, outlining priorities for FY26, and responding to questions. Key topics included the reprogramming of School Health Services, health systems changes, the new Animal Control contract, and anticipated federal funding cuts.
- A markup was held on June 23, 2025 and will now go before the Committee of the Whole. In that mark-up, changes include:
 - Fully funding the CON Improvement Act across its financial plan
 - Allocating over \$1.3 million to partially restore HIV prevention and surveillance grant and \$411,000 to the Health & Wellness Center to expand hours
 - Enhancing funding for food access programs at DC Health
 - Several investments to strengthen the healthcare workforce such as:
 - Fully funding the Counseling Compact Approval
 Act
 - Proposing and funding Budget Support Acts (BSA) for:
 - DC Health Licensure Pathways Program (will enable DC Health to assist internationally trained health professionals in obtaining their licensure and credentials required to practice in the District)
 - Certified Nurse Aide Workforce
 Amendment Act (transfers \$150,000 to the Committee of the Whole which will go to OSSE to partner with a local university to train at least 25 district high school students to become certified nurse aides)

 Health Occupation Criminal Background Check (will streamline background checks for health professional renewals in partnership with MPD)

Certificate of Need Improvement Amendment Act:

- Councilmember Henderson introduced the Certificate of Need Improvement Amendment Act of 2025 (<u>B26-0025</u>) on January 6, 2025.
 - The legislation reforms the Certificate of Need (CON) process, while also establishing a new registration program for certain health facilities (including private clinics).
- The legislation was signed by the Mayor on April 22, 2025 and became official law on June 10, 2025.

FIFA Legislation:

- On May 19th, Chairman Mendelson introduced the Health Occupations Revision Exemption Emergency Amendment Act of 2025 (<u>B26-0250</u>) and the Health Occupations Revision Exemption Temporary Amendment Act of 2025 (<u>B26-0251</u>) for the upcoming FIFA's Club World Cup 2025 competition.
 - This legislation exempts the healthcare professionals who are not licensed in the United States but are licensed in good standing in foreign countries, be able provide continued care to the members of their teams and staff while in the District.
- Emergency (effective up to 90 days) and temporary (effective up to 225 days) legislation do not receive a hearing. The emergency bill was enacted on June 3, 2025, and the temporary bill is under Mayoral review.

Background: The Multiple Sclerosis and Neuroimmunology Fellowship program will be offered through the Department of Neurology at Medstar Georgetown University Hospital as a non-ACGME accredited program. This is a one-year, full-time clinical training program, with an optional second year available for fellows interested in advanced training in clinical or translational research. As the treatment landscape for MS continues to rapidly evolve with increasingly complex, immunetargeting therapies specialized neuroimmunology training is essential. Due to a national shortage of fellowship-trained neurologist, the American Academy of Neurology has identified MS as a critically underserved area. **Motion:** Motion made by Dr. Madkour to approve the Multiple Sclerosis and Neuroimmunology Fellowship Program. FSMB RECOMMENDATIONS ON THE REGULATION OF PHYSICIANS
IN TRAINING

Board Action:

To review and discuss FSMB Recommendations 2 and 6 in the context of the Board of Medicine's current policy and practices for physicians in training.

Background:

In 2024, the Federation of State Medical Boards (FSMB) House of Delegates adopted the recommendations of the Workgroup on the Regulation of Physicians in Training as best practice guidance for state medical boards. These recommendations are intended to modernize, streamline, and strengthen the oversight of physicians in training while promoting consistency across jurisdictions. Currently, the District of Columbia has over 1470 physicians in training holding Medical Training Licenses (MTL) – Categories A and B.

This item is brought before the D.C. Board of Medicine specifically to consider the applicability of FSMB Recommendations 2 and 6 to the District:

Recommendation 2: State medical boards should issue resident training licenses extending for the duration of a GME program, rather than a license that is renewed annually, as long as the licensee is annually reported to the state medical board by the training program as being actively enrolled and in good standing.

Recommendation 6: State medical boards should apply recommendations in FSMB's Report and Recommendations of the Workgroup on Physician Wellness and Burnout adopted by FSMB's House of Delegates in 2018, related to health-related application questions for full and unrestricted licensure to resident license applications. State medical boards should consider opportunities for periodic outreach to medical students and residents about medical expectations and concern for their well-being.

MEDICAL TRAINING LICENSE (MTL) ISSUANCE CYCLE

Board Action: To realign the Medical Training License (MTL) issuance cycle with the structure of postgraduate clinical training programs in the district.

SC

Background:

Current regulations restrict Medical Training Licenses (MTLs) to a one-year validity period, with a standard effective date of July 1. This date was originally chosen to coincide with the traditional start of clinical duties for most graduate medical education (GME) programs.

However, many residency and fellowship programs have shifted their schedules, now beginning orientation and onboarding in mid-June. Increasingly, these early activities involve clinical exposure that requires active licensure. As a result, there is now a regulatory gap: trainees may be engaging in clinical activities before their licenses become effective, exposing both institutions and individuals to legal and professional risk. Additionally, as many programs conclude in the last week of June, the end date of the license is also critical to ensure continuous coverage.

Options for Board Consideration

To address this misalignment, the following options are presented for the Board's consideration:

Option 1 – Extend Initial MTL to 13 Months. Allow the initial MTL to begin on June 1 and expire on June 30 of the following year (a total of 13 months). Subsequent renewals would revert to the standard 12-month cycle.

Option 2 – Shift Standard MTL Cycle to June–May. Redefine the MTL licensing year as June 1 to May 31 for both initial and renewal licenses, aligning the cycle with the current structure of most training programs.

Option 3 – Develop a Multi-Year MTL Model. Create a three-year MTL option, with renewals available at either one-year or three-year intervals, all expiring on June 30.

CONTINUING EDUCATION REQUIREMENTS

Board Action: To determine whether and how the Board should prorate or adjust the required Continuing Education Unit (CEU) hours for licensees whose renewal cycles have been shortened due to the transition to a birth month/birth year renewal schedule.

Background:

All health professional licensing boards in the District of Columbia transitioned to a birth month/birth year-based renewal cycle. This change was implemented to improve administrative efficiency and simplify license tracking for both the Board and licensees.

As a result of this transition, some licensees have received license terms of less than the standard two years. This presents a challenge, as the Board's current policy assumes a two-year license cycle when evaluating CEU compliance. Given that CEUs are a requirement for license renewal, the Board must now determine an equitable policy for the affected licensees that ensures fairness while maintaining the integrity of continuing education expectations and public protection.

One proposed recommendation is that affected licensees be required to complete 50% of the standard CEU hours, including all mandatory content areas (such as LGBTQ+ cultural competency and DC Health public health priorities).

Motion: Motion made by Dr. Pavuluri if they are renewing less than the two-year cycle, they will only have to complete 50% of the standard CEs. Seconded by Dr. Fosu.

	In 2021, as part of the FY 2022 Budget Support Emergency Amendment Act, the practice of doulas was added to the Health Occupations Revision Act (HORA) under the regulatory authority of the DC Board of Medicine.	
	In 2022, the criteria and scope of practice for doulas were amended slightly, and the profession was placed under the oversight of the newly created Advisory Committee of Maternal Care Professionals. While the statutory foundation has been established, the implementing regulations for the practice of doulas in the District of Columbia remain to be finalized.

	Subsequent legislation amended the composition and scope of the Advisory Committee to include doulas, and it was renamed the Advisory Committee on Maternal Care Professionals. The Advisory Committee was first convened in 2023.	
	Since that time, committee members have worked to develop implementing regulations for the practice of certified professional midwives.
