# 2011 IS THE YEAR TO RENEW!

All licensees will be able to begin to access renewal forms online beginning in October 2010. Please remember that only **CEUs obtained in the two years immediately preceding the renewal date will be accepted**. You are to have completed **twelve (12) hours** of approved continuing education credit at the time of renewal:

- Three (3) hours of professional ethics
- Nine (9) hours of massage-related course work provided by a Board-approved provider of which six (6) hours shall be completed in a live classroom setting taught by an appropriate instructor.

CEUs are not required for those who are first-time renewal applicants who were licensed by exam or were enrolled in an approved training program during any part of the two-year period prior to approval.

ALL LICENSES EXPIRE ON JANUARY 31, 2011. The renewal period will end midnight January 31, 2011. The Board of Massage Therapy will conduct a random CEU audit immediately following the renewal period.

**EXPEDITE YOUR LICENSE:** Make sure to have your entire application filled out and signed. You must provide "official" supporting documentation to any and all application questions and/or statements that require a detailed explanation. Official court documents of final case dispositions for any felonies or misdemeanors that you incurred (i.e., a defendant, in any state or country) should be included; malpractice case dispositions should include a case number, jurisdiction, year, all the defendant names, all plaintiff names, a brief summary of the case, and final disposition, such as judgment dollar amount, dismissed with or without prejudice, or settlement dollar amount—this information must be sent with your application.

**PAID INACTIVE STATUS:** If you intend to retire your license, or if you would like to place your license on Inactive Status, you must explicitly inform the Board of your intention before the renewal date expires. If you fail to pay renewal fees on time, your license is not inactive; it is delinquent (expired). It is unlawful to practice while your license is delinquent/expired.

#### TO RENEW ONLINE YOU MUST USE INTERNET EXPLORER 6.0 OR HIGHER AND PAY BY MASTERCARD OR VISA. OUR SYSTEM IS NOT COMPATIBLE WITH MOZILLA FIREFOX, GOOGLE CHROME OR SAFARI.

FOR NEW USERS: You must register to select a User ID and Password. In order to uniquely identify yourself to register to use our online application, you need to have your SSN handy and your last name (as it appears on your application/renewal notice or Weblookup) for an easy and quick registration. For existing users, you need to click on the log-in button and proceed from there with your User ID and password.

Before you log-on to our website, please have these items available: Your Social Security number Your Visa or MasterCard, in order to pay your renewal fee of \$179 online.

### VERIFICATION OF LICENSURE

Licensing authorities and some health facilities often require a letter of verification of the licenses you currently hold or have held in the past. These letters of verification are sometimes called "letters of good standing," even though your DC license may have expired.

If the jurisdiction or institution to which you wish the letter sent gave you a form, simply forward the form, with a check or money order payable to "DC Treasurer" in the amount of thirty-four dollars (\$34.00) to:

On the form, be sure to include your name and the address of where the form should be sent.

MEET BOARD OF MASSAGE THERAPY MEMBER KATHY ENGLISH-HOLT, MT

### When were you appointed to the Board?

I was appointed in October of 2009.

#### Why and how did you first get involved with the Board? What sparked your interest in serving as a Board member?

I thought it would be a good way to serve my community since it has been my profession for 18 years.

### What issues, related to the regulation of your profession, interest you most?

I am a Reiki practitioner and teacher, in addition to being a massage therapist, and have real concerns about energy work being licensed under massage therapy. Reiki is spiritual healing work NOT massage therapy. Our definition of massage as it is written in the rules needs to be looked at with regard to this work.

# What challenges lay ahead for the Board?

We need a more diverse board. We will be looking at other modalities as they continue to appear. I am also concerned about those who will come up for licensure with regard to education, prior experiences, etc. We want to maintain excellence without discriminating.

#### Is there anything about the District of Columbia or the DC population that poses a unique challenge to your profession?

The educational level and economics for young people in our city is disturbing and many view massage therapy as a quick way to make money due to the heavy advertising by for-profit schools on radio and television. These schools offer student loans and have a very simple and open admissions process. Due to the intimate nature of our work (only a sheet separates us from our clients), our professional schools need to have a very rigorous and thorough admissions process. Individuals who choose this path need to be screened and supervised throughout their training.

### What future goals do you have as a Board member?

I would like for the Board to reevaluate legislating energy work.

### What unique perspective do you bring to the Board (if any)?

My extensive experience as an instructor at Potomac Massage Training Institute gives the Board an educational perspective—what we teach and how we teach. I also have taught hundreds of students over the years and have some deeper insight as to what some of their issues are with regards to protocol, practice and professionalism. I am also very entrenched in the metaphysical spiritual community in Washington, DC and am exposed to those who practice Reiki and other energy work.

### Any message you would like to convey to your Board's licensees?

The message I would like to convey is integrity is of utmost importance. It is also very important to recognize that what you do today affects tomorrow. The law of cause and effect is always at work. Finally, I would like licensees to spread the word that illegal activity will not be tolerated. We have come a long way since the days of massage parlors, and we need to be steadfast in our commitment to morality, ethics and integrity in our profession.

### When were you appointed to the Board?

I was appointed in January of 2010.

#### Why and how did you first get involved with the Board? What sparked your interest in serving as a Board member?

I was burnt out from "involvement overload" a few years back, and after lying low for a while, I decided it was time for me to once again become more involved with the leadership aspects of my profession.

# What issues, related to the regulation of massage therapy, interest you most?

What I find most interesting is the issue of the ever-changing education and training standards in the massage profession.

#### Is there any aspect of your service as a Board member thus far that has surprised you?

I have been surprised by the minimal amount of time that the Board actually comes together to act. Matters coming before the Board for action sometimes will have to wait more time than I would think they should have to wait, due to the fact that we meet so infrequently.

# What challenges lay ahead for the Board?

One of the most significant challenges for the Board will be updating the existing Regs and doing away with irrelevant, outdated restrictions as well as contradictions in policies.

#### Are there issues regarding your profession that pose special challenges for establishing regulations?

There are many types of bodywork that commonly are equated with massage therapy. In some cases, it could be argued that a particular discipline (such as Reiki) might not be considered massage therapy, and therefore should not be governed by the laws regulating massage therapy. I feel that this is like splitting hairs and, practically speaking, most of these disciplines would fit the definition of massage therapy. However, this viewpoint is sometimes challenged, which means that the Board must rule on the issue. It can be tricky deciding on things like this without making someone unhappy.

# What future goals do you have as a Board member?

I would hope that we can accomplish an effective update of the Regs, so one part [of the regulations] no longer contradicts another part, and what is contained in them is clear and sensible. I hope that we, the Board members, can provide constructive input for this process and help the staff carry out this hefty task with greater ease and in a timely fashion. The licensees and the public deserve this!

# What unique perspective do you bring to the board (if any)?

I bring my 25 years of experience as a practicing massage therapist to my position on the Board. Over the years, I have witnessed and, in my own small way, contributed to, the dramatic increase in the popularity and acceptance of massage therapy as a legitimate health care option in this country. I helped work to create state regulation of the massage therapy profession for the State of Maryland, over a period of ten years, while living in Maryland. I was the co-founder and director of the first Sports Massage Team in the Washington, DC area, one of the first in the country

to charge for our services. I have maintained professional relationships with fellow massage therapists from across the country and have had an opportunity to discuss with them common pertinent issues related to the massage therapy profession since 1985.

These things, I believe, give me a unique perspective with regards to the evolution of the massage therapy profession over the past two decades, and I hope to bring that experience to my service on the Board.

#### Any message you would like to convey to your Board's licensees?

I would like to remind all licensees that they carry a significant level of responsibility interacting with the public, not only to their clients, but to themselves and to their profession. Given the close, trusting nature of the massage therapist-client relationship, it is essential that a massage therapist be a person with character beyond question. It is also important to grow and to expand your skills and breadth of knowledge of massage therapy. This is the standard that you should endeavor to maintain.

### CRIMINAL BACKGROUND CHECK FOR NEW APPLICANTS

Beginning in November 2010, each new applicant for a health care license, registration or certification will need a criminal background check as part of the licensure process. The new rules are set forth in Title 17 of the District of Columbia Municipal Regulation Chapter 85. The cost will be fifty dollars (\$50) payable at the time the application is submitted. Applicants will need to start the process by going to the DC Metropolitan Police Department to have their fingerprints taken or, if applying from out-of-state, by obtaining a fingerprint card from the DC Health Regulation and Licensing Administration and having their fingerprints taken at the local or state police agency. The FBI will require 48 hours to conduct the Criminal Background Check. Adverse information will be reviewed by the Board of Massage Therapy.

### HONESTY IS THE BEST POLICY: REPORTING DWIs, DUIs, AND OWIS

According to a 2009 National Highway Transportation Safety Administration report, in 2008, an estimated 11,773 people died in drunk driving crashes involving a driver with an illegal Blood Alcohol Content (0.08 or greater). These deaths constitute 31.6 percent of the 37,261 total traffic fatalities in 2008. There are increasing reports of people who think "driving while buzzed" is not as dangerous as driving while intoxicated. This is not the case. In Washington, DC any amount of drinking and driving can be cause for legal action.

Washington, DC has three different types of "drunk driving" violations:

1. Driving While Intoxicated (DWI) is the act of operating or being in physical control of a motor vehicle with a blood alcohol level of 0.08 or higher. 2. Driving Under the Influence (DUI) is the act of operating or being in physical control of a motor vehicle "under the influence of alcohol" and this can mean a blood alcohol level as low as 0.05 or if you show that you are impaired by alcohol to an "appreciable degree." 3. Operating While Impaired (OWI) is the act of operating or being in physical control of a motor vehicle while you are so affected by the consumption of alcohol that it impairs your ability to operate a motor vehicle in the same way a reasonably careful and prudent driver, not so impaired, would operate a vehicle in similar circumstances.

Most people are probably familiar with DWI and DUI, however they may not be aware of the OWI law in DC. One need not have an illegal BAC or fail a field sobriety test to be convicted of an OWI. OWI is the easiest of the three types of "drunk driving" violations for a prosecutor to prove and as a result the penalties for an OWI conviction are lighter than those for a DUI or DWI.

Question 7b on the application for licensure asks if you have ever been convicted or investigated of a crime or misdemeanor (other than minor traffic violations). Despite the low threshold for proof, an OWI conviction or investigation must be reported on your application for licensure. The Board takes an OWI conviction just as seriously as we would a conviction for a DWI or DUI. Answering "yes" to question 7b is not cause for automatic exclusion from licensure. Each application for licensure that has a "yes" to question 7b is reviewed individually. As always, honesty is the best policy.

IMPAIRED OPERATION OF A VEHICLE: PLEASE NOTE THAT, IN ADDITION TO ALCOHOL, IMPAIRMENT CAN ALSO BE CAUSED BY LEGALLY-OBTAINED MEDICATIONS OR ILLEGAL SUBSTANCES.

### FILING A COMPLAINT WITH THE BOARD

To file a complaint against a licensed Massage Therapist, simply write a letter that describes your complaint. The letter must be signed, and you should attach copies of any pertinent documents that you may have.

The letter must also include your address, so we may contact you as necessary and notify you of any findings.

You can also fax your complaint about unlicensed activity to (202) 724-8677.

Please be advised that the health professional licensing boards do not have jurisdiction over fee disputes, except for billing for services that were not provided. If you have a fee dispute with a health professional, you can seek redress through the civil courts.
