Please include your name, address, Social Security number and license number, and email address.

If you have a name change, you must also enclose a copy of your certificate of marriage, divorce decree, or court order that authorizes the change.

Current Renewal Cycle: February 1, 2015 – January 31, 2017 Next Renewal Period: November 1, 2016 – January 31, 2017

# IMPORTANT INFORMATION FOR NEW APPLICANTS

All applicants are required to answer all screening questions truthfully. Failure to answer application questions truthfully may delay the processing of your application and may necessitate Board action.

# **RENEWAL TIPS**

- · CAREFULLY read all renewal screening questions.
- If you respond "Yes" to a screening question, you must explain fully and provide all pertinent documentation (including court records in the case of an arrest).
- If you respond "no" to the continuing education completion question, you MUST provide complete documentation before your license will be renewed.

# CONTINUING EDUCATION (CE/CEU) INFORMATION

Twelve (12) CE's must be taken between February 1, 2015 – January 31, 2017.

If you are renewing for the first time, CE's are not required.

All other Massage Therapists must complete twelve (12) hours of Board approved continuing education:

- Three (3) hours in Ethics
- Nine (9) hours in a massage-related course of which six (6) hours must be face to face instruction and the other three (3) hours may be online instructions.

### **AUDIT INFORMATION**

After renewal you may be audited and required to submit continuing education (CE) documents and current **CPR** and **FIRST AID** certificates to the Board.

# **PAID INACTIVE STATUS**

If you intend to retire your license, or if you would like to place your license on Inactive Status, you must explicitly inform the Board of your intention before the renewal date expires. If you fail to pay renewal fees on time, your license is not inactive; it is delinquent (expired). It is unlawful to practice as a Massage Therapist while your license is delinquent/expired.

PAID INACTIVE FEE: \$177 (one-time fee)

TIME LIMITATION: UNLIMITED

FEE TO REACTIVATE

YOUR LICENSE: \$ 34

# **CONTINUING EDUCATION (CE):**

Licensees on Paid Inactive status must continue to meet the continuing education requirements; CE must be presented to the Board when applying for licensure reactivation.

# FILING A COMPLAINT WITH THE BOARD

PLEASE NOTE: To file a complaint against a licensed Massage Therapist, complete a complaint form from our website at http://doh.dc.gov/service/file-complaint-health%20prof

Please be advised that the health professional licensing boards do not have jurisdiction over fee disputes, except for billing for services that were not provided. If you have a fee dispute with a health professional, you can seek redress through the civil courts.

You may also write a letter to the Board that describes your complaint. To file a complaint against a licensed Massage Therapist, simply write a letter that describes your complaint. The letter must be signed, and you should attach copies of any pertinent documents that you may have. The letter must also include your address, so we may contact you as necessary and notify you of any findings.
