LETTER FROM THE ACTING CHAIR

Welcome to your renewal issue of the District of Columbia Board of Massage Therapy. This newsletter is published yearly, and this will be our primary means of communication with all DC licensed Massage Therapists.

The Board will now be distributing its newsletter by email. Thus, it is essential that you update your email address with the Board to ensure that you receive upcoming newsletters and important notifications regarding regulatory updates and changes. You may submit your updated email address to Ms. Thelma Aboagye at thelma.aboagye@dc.gov.

The renewal deadline is January 31, 2013, so please begin to gather your continuing education (CE) credit certificates. Each year, the Board audits a number of Massage Therapists to determine if the credits listed on the license renewal application are accurately reflected

in the credits on hand. The Board continues to address issues with a number of Massage Therapists who cannot accurately validate their credits for a number of reasons. Please note that reporting on the license renewal that you have accumulated the required credits, but later being unable to verify them in an audit can result in disciplinary action. Please ensure that you have—or will have accrued—the necessary credits by January 31. For this renewal cycle, Massage Therapists are required to have twelve (12) hours of approved CE credits during the two (2) year period preceding the date the license expires. The new CE Audit Response Form is on page 5 and on the Board website at www.hpla.doh.dc.gov

There is another important requirement that will impact the renewal process for the very first time this year. It is the need for each Massage Therapist and all other health professionals to undergo a criminal background check (CBC).

A delineation of the CBC process can be found in this newsletter (please see page 3). Please read and follow these instructions. Should you have any questions, call the Board's staff listed on the back of the newsletter.

WHEN YOU MOVE (OR CHANGE YOUR NAME)

Licensees sometimes forget to inform the Board of Massage Therapy when they move or change names. If we do not have your current address, you may not receive your renewal mailing because we may send it to your former address.

All name and address changes must be submitted in writing to our office within 30 days of the change.

Please include your name, address, Social Security number and license number, and email address.

If you have a name change, you must also enclose a copy of your certificate of marriage, divorce decree, or court order that authorizes the change.

THINGS YOU NEED TO KNOW TO RENEW

- 1) All licensees will be required to undergo a state and federal Criminal Background Check (CBC). If you were licensed after January 2011, and already underwent a CBC for DC licensure, you are exempt from this requirement.
- 2) To access your renewal application beginning on November 1, 2012, go online at www.hpla.doh.dc.gov. No CBCs will be done/accepted unless a renewal application has been completed and filed with our office.
- 3) Answer **ALL** questions completely and truthfully to avoid delays in processing your application. If you are aware of an incident in your past that may result in a positive criminal background check, you must provide the supporting documentation (including court documents) that explains the outcome of the case.
- 4) If you are currently not in compliance with the Board, your ability to renew may be denied until you satisfy the request of the Board.
- 5) The licensure renewal fee is \$177. In addition, Criminal Background Check fee is \$50.* *varies by state
- 6) CE's—All licensees must have completed 12 hours of continuing education (CE) credits prior to renewal to be eligible for renewal. Random audits will be conducted following the renewal.
- 7) All licenses will expire on January 31, 2013. Please begin the renewal process early.

Any false statement on your renewal application will result in disciplinary action being taken against your license.

LICENSURE RENEWAL PROCESS

LICENSES EXPIRE ON JANUARY 31, 2013

RENEW YOUR LICENSE VIA THE INTERNET.

TO RENEW ONLINE YOU MUST USE INTERNET EXPLORER 6.0 OR HIGHER AND PAY BY MASTERCARD OR VISA. OUR SYSTEM IS NOT COMPATIBLE WITH GOOGLE CHROME OR SAFARI.

Before you log-on to our website, please have these items available:

Your Social Security number

Your Visa or MasterCard, in order to pay your renewal fee of \$177 online.

WHEN YOU ARE READY TO LOG-ON TO OUR WEB SITE:

· Enter www.hpla.doh.dc.gov into the address field of your web browser

Click on Online License Renewal

Type in your Social Security number and last name and click on "Search" tab

At the Registration page, you must create a User ID and Password

Type in your newly created User ID and Password and follow the step-by-step instructions to complete the renewal process.

• Please be sure to printout a copy of the "Confirmation Page" for your records.

AFTER YOU FINISH THE ON-LINE RENEWAL AT OUR WEB SITE, SEND US:

- If you do not currently have a photo on your license, you will need to send TWO (2) 2"x2" photos of yourself (identical passport-size photos; plain background, front-view, fade-proof), and write on the back of the photos your full name and license number or Social Security number.

CEs are NOT required for first-time renewals.

PAID INACTIVE STATUS

If you intend to retire your license, or if you would like to place your license on Inactive Status, you must explicitly inform the Board of your intention before the renewal date expires. If you fail to pay renewal fees on time, your license is not inactive; it is delinquent (expired). It is unlawful to practice as a Massage Therapist while your license is delinquent/ expired.

PAID INACTIVE FEE: \$177 (one-time fee)

TIME LIMITATION: UNLIMITED

FEE TO REACTIVATE YOUR LICENSE: \$ 34

CONTINUING EDUCATION (CE): Licensees on Paid Inactive status must continue to meet the

continuing education requirements; CE must be presented to

the Board when applying for licensure reactivation.

CRIMINAL BACKGROUND CHECK (CBC) PROCESS

WHERE CAN I GET MY CRIMINAL BACKGROUND CHECK DONE?

Health professionals licensed in the District of Columbia can now receive live scan Criminal Background Check services with MorphoTrust USA (formerly called "L-1 Enrollment"). For more information on how to receive a live scan Criminal Background Check via MorphoTrust Services visit the MorphoTrust USA website or call 1-877-783-4187.

APPLICANTS COMPLETING CBC THROUGH MORPHOTRUST USA

Applicants choosing to use MorphoTrust USA for CBC will pay MorphoTrust directly for this service. Applicants have the following options to schedule fingerprinting appointments with MorphoTrust USA.

- 1. On-line Live-Scan Scheduling
 - Available 24 hours a day, 7 days a week.
 - 1. Go to the website, www.L1enrollment.com.
 - 2. Click on the map link to DC.
 - 3. Choose Online Scheduling and enter required information and select desired appointment.
- 2. Call Center Scheduling
 - Available Monday Friday, 9am 5pm EST.

Call (877) 783-4187 and speak to one of the operators.

- 1. Operators will collect required information and schedule your appointment.
- 2. Be sure to write down your appointment date, time and location provided by the operator.
- 3. Out of State Applicants who reside out of the District of Columbia, or are physically unable to go to a location to be fingerprinted may use MorphoTrust USA's Card Scan Processing Program.

This program utilizes advanced scanning technology to convert a traditional fingerprint card (hard card) into an electronic fingerprint record. Converting a "hard card" into an electronic record enables an applicant to have their fingerprint record processed as quickly as if they had traveled to an electronic fingerprint processing location. Applicants must go online to the MorphoTrust USA website or call 1-877-783-4187.

** A FBI Name Search request will be requested by MorphoTrust (formerly doing business as L-1 Enrollment) on behalf of DC DOH if an applicant has received two fingerprint rejections based on quality. Once MorphoTrust personnel receive notice that an applicant has received a second rejection, a name search request form will be submitted by approved MorphoTrust personnel directly to the FBI.

CAN I APPLY FOR A TEMPORARY LICENSE IN THE DISTRICT? The Board does not issue Temporary Licenses.



TWO CHECKS!

Your first check, made payable to "DC Treasurer", will cover the fee for your renewal. Your second, separate check will go towards the Criminal Background Check (CBC); that fee is \$50 for DC residents. CBC fees vary by state.

LICENSED AFTER JANUARY 2011

If you were licensed after January 2011, and already underwent a CBC for DC licensure, you are exempt from this requirement for this renewal.

PREVIOUS HPLA CBC

If you have completed a CBC for the purpose of licensure with DC Health Professional Licensing Administration (HPLA), you are not required to complete another CBC until 2016.

CBC FINGERPRINT VENDOR LOCATED AT DOH

You can get your CBC fingerprinting done at the MorphoTrust location on the first floor at the Health Professional Licensing Administration. We are located at 899 North Capitol Street, NE, Washington DC 20002 (across the street from Gonzaga High School).

SUBMIT RENEWAL APPLICATION BEFORE CBC

No CBCs will be done/accepted unless a renewal application has been completed and filed with our office.

OF NOTE: MASSAGE ESTABLISHMENT LAW

Subtitle 25-D of the D.C. Municipal Regulations (Massage Establishment and Health Facility Regulations) was revised on October 9, 2009 with the goal of strengthening the standards for massage establishments and health spa facilities. The regulations require licensure for massage establishments which are defined as establishments where massage is provided or administered. A massage establishment is required, among other things, to have a manager on duty during all hours of operation.

The licensure and related requirements have recently been noted to have unintended and burdensome impact on massage therapy professionals. Accordingly, the Department of Health (DOH) has embarked upon an effort, with valuable input and insight from the massage therapy community, to revise the regulations to clearly exempt massage therapists from the establishment regulations. The exemption will mean that massage therapists who own a massage practice or establishment are not required to obtain a massage establishment license from DOH.

The proposed regulations are expected to be published in October or November in the D.C. Register. The Board of Massage Therapy will send an e-mail blast to alert licensees and invite public comments on the proposed rules. The D.C. Register is available at **www.dcregs.org**. Interested individuals may create an account at the D.C. Register website to receive e-mail notifications of any activities, notices, or rules.

FREQUENTLY ASKED QUESTIONS

When do I renew my license? Massage Therapy licenses are renewed every two (2) years by January 31st of each odd-numbered year.

What are the Continuing Education (CE) requirements for the renewal cycle? Licensees must have completed twelve (12) hours of approved continuing education credit during the two (2) year period preceding the date the license expires, which shall consist of the following: (a) Three (3) hours of professional ethics; and (b) Nine (9) hours of massage-related course work provided by a Board approved provider of which six (6) hours should be completed in a live classroom setting taught by an appropriate instructor.

You will have to attest that you have in fact fulfilled your CE requirement. Only licensees selected during random audit may be subject to verify their CE by submitting copies of their certificates of completion.

Do I need to submit the twelve (12) hours of approved CE credits if this is my first renewal? No. If this is your first renewal, you do not have to submit CE credits.

May I place my license on Paid Inactive if I allow my license to expire after January 31, 2013? You may place your license on Paid Inactive during the sixty (60) day grace period with a payment of the \$85.00 late fee, plus a Paid Inactive fee.

Can I reinstate my expired Massage Therapy license in the District of Columbia? Yes, provided that your license has not been expired for more than five years. You must complete the required continuing education credits for reinstatement and submit the appropriate application.

How do I request a letter of verification from the District of Columbia Board if I am applying to another jurisdiction? Submit a written request to the Board including your name, license number and the address to which you would like the verification sent. Also include any form that needs to be completed by our agency. Include a check or money order for \$34.00 made payable to the DC Treasurer. Once your request is received, verification will be processed within 5-7 business days.

Do I need to complete a criminal background check if I have already completed it for my employment? Yes, the criminal background check must be done for the DC Massage Therapy license.
