CONSENT ORDER

Jurisdiction

This matter comes before the District of Columbia Board of Chiropractic (the “Board”) pursuant to the Health Occupations Revision Act (HORA). D.C. Official Code § 3-1201.01, *et seq.* (2009). The HORA authorizes the Board to regulate the practice of chiropractic in the District of Columbia. The Board has broad jurisdiction to regulate the practice of medicine and to impose a variety of disciplinary sanctions upon a finding of a violation of the HORA. D.C. Official Code, § 3-1205.14; *Mannan v. District of Columbia Board of Medicine*, 558 A.2d 329, 333 (D.C.1989). The Council of the District of Columbia, in amending the HORA, “intended to strengthen enforcement of its licensing laws.” *Davidson v. District of Columbia Board of Medicine*, 562 A.2d 109, 113 (D.C.1989). And the HORA “was designed to ‘address modern advances and community needs with the paramount consideration of protecting the public interest.’” *Joseph v. District of Columbia Board of Medicine*, 587 A.2d 1085, 1088 (D.C.1991) (*quoting* Report of the D.C. Council on Consumer and Regulatory Affairs on Bill 6-317, at 7 (November 26, 1985)) (emphasis added by court)).

Background

The Respondent has been licensed in the District of Columbia to practice chiropractic since 2004. Since then, Respondent has practiced chiropractic in the District without incident. During the last renewal cycle, the Board conducted an audit of a random number of licensees to determine compliance with the continuing education (CE) requirement. This audit revealed that Respondent has not complied with the CE requirement, and is deficient by 24 hours of CE. The Board has become aware that Respondent has failed to attain the requisite number of CE credits to be eligible to renew her license.

Conclusions of Law

The Board is authorized to sanction Respondent under the HORA for his actions, which are related to the practice of medicine. The HORA provides, in pertinent part:

Each board, subject to the right of a hearing as provided by this subchapter, on an affirmative vote of a quorum of its appointed members may take one or more of the disciplinary actions provided in subsection (c) of this section against any applicant for a license, registration, or certification, an applicant to establish or operate a school of nursing or nursing program, or a person permitted by this subchapter to practice a health occupation regulated by the board in the District who:

* * *

(24) violates any provision of [the HORA] or rules and regulations issues pursuant to the HORA[.]

D.C. Official Code § 3-1205.14(a)(24). The HORA further provides:

The Mayor may establish by rule continuing education requirements as a condition for renewal of licenses[.]

D.C. Official Code § 3-1205.10(b). Chiropractors actively practicing chiropractic in the District of Columbia must submit proof of having completed 24 hours approved continuing education credit during a two-year period preceding the date the license expires. DCMR §17-4806.4.

Respondent has violated the foregoing requirements necessary to maintain his license to practice chiropractic. Accordingly, Respondent's conduct described above provides the Board with a basis in fact and law to warrant disciplinary action.

ORDER

ACCORDINGLY, based upon the foregoing, it is this 14 day of January, 2014, by the District of Columbia Board of Chiropractic hereby,

ORDERED, that a fine of \$300 be and is hereby imposed upon Respondent for failing to comply with the CE requirement to maintain his licensure requirements; and it is further

ORDERED that, upon the Board's acceptance of this Consent Order, Respondent shall complete 24 credits of deficient CE credits within six months of the effective date of this Consent Order, in addition to any CE requirements for the current license term; and it is further

ORDERED, that all fines imposed herein shall be paid within 30 days of the effective date of this Consent Order; and it is further


ORDERED, that Respondent submit proof of completion of the deficient CE credits, in addition to the number of credits required to maintain Respondent's license in good standing during the current two-year license term; and it is further

ORDERED, that this is a public document.

Any violation of this Order may constitute grounds for suspension or revocation of Respondent's license, after due notice and hearing. In the event Respondent violates this Order, an administrative proceeding may be convened to determine whether such action is warranted. Any fine imposed by the Board shall be made by check payable to the "D.C. Treasurer" and submitted to Deniz Soyer, Health Licensing Specialist, Board of Chiropractic, 899 North Capitol Street, NE, 2nd Floor, Washington, D.C. 20002.

Respondent shall maintain a course of conduct in his practice of medicine commensurate with the requirements of all laws and regulations of the District of Columbia regarding the practice of medicine.

- I further expressly acknowledge that by signing this Consent Order, I am waiving my right to appeal this Consent Order, as well as waiving any and all rights, whatsoever, I would have to challenge or appeal that Board's decision to suspend my license based on the failure to satisfactorily fulfill the terms of the Consent Order. A.Y. (initial)

• I acknowledge that in the event that the Board suspends my license based on the failure to satisfactorily fulfill the terms of the Consent Order, my sole remedy and recourse will be to respond within the time period set forth in this Consent Order with proof of my compliance and that if I fail to do so, my sole remedy and recourse will be to comply with the terms of this Consent Order to the satisfaction of the Board.
